President's Report for the Association for Canadian Studies and

Metropolis Canada

Despite the important challenges that the Association for Canadian Studies encountered owing to the ongoing impacts of the pandemic, the last year proved to be the most active in the history of the ACS. The organization pivoted quite successfully to virtual events and the Metropolis Canada conference attracted over 1000 participants online. The annual history conference yielded over online 500 attendees. But it was in the area of research that the ACS experienced record growth as we moved swiftly to create the COVID-19 Social Impacts Network which included participants from several government departments, representation from civil society as well as academic researchers from many disciplines. The network saw the ACS undertake a wide range of new research projects thus contributing to an unprecedented expansion of our research capacity. Also, funding for our largest research project the Canadian Index for Measuring Integration was renewed during the year and we're working to expand the index to include indicators for measuring inclusion.

The year 2020-2021 saw the Association for Canadian Studies emerge as the most frequently quoted organization of its type in Canada with citations for the year near equal to the combined total for what are widely regarded as Canada's 18 leading think tanks.

With the expansion of Metropolis initiatives, this year offered an opportunity for reflection about our branding and the relationship between the Association for Canadian Studies and the various Metropolis projects. It was decided to keep the brands distinct from each other rather than combining them and the various Metropolis projects would be part of what will be called the Metropolis Institute. One of the new and rapidly expanding initiatives emerging from Metropolis is e-learning and in this regard *uMetropolis* was created. We surveyed some 300 Metropolis conference participants and over 90% expressed a willingness to take courses under the uMetropolis brand to further their professional development. We propose to co-develop most of the courses with

In the midst of continuing challenges arising from the contagion, the professional team stepped up in an important way. Report from the Treasurer of the Association for Canadian Studies and Metropolis Canada

Despite the ongoing challenges arising from the contagion the ACS finances were stable for the fiscal year 2020-2021. On the basis of annual operations we generated a deficit of \$1,217 from the annual operations of the Association based on record levels of revenue of \$1,367,340 and expenditure at \$1,368,557.

There was an important diversification in the share of revenues arising from multiple research projects associated with assessing the social and economic impacts of COVID-19. Funding for the Metropolis conference fell further owing to the continuation of income reduction from lower registration charges for online events. Canadian Heritage's share of overall revenue dropped below 25% relative to the previous year.

Overall the Association for Canadian Studies reserve fund (unrestricted net assets) stood at \$131,870.



Webinar, December 15, 2020

This event was presented as a Metropolis North America event with the partnership of The Refugee Council, USA and was marketed to both our Metropolis North America audience as well as our entire network.

The event addressed the reality that COVID-19 had fundamentally altered the flows of international migrants and the movement of people between the United States and Canada. At the time of the event, the borders between the two countries had been closed for several months and majorities in both countries were not ready for reopening in the near term. A theme of the event included the pending entry of the Biden-Harris administration and the changes we could expect in relations between our two countries especially around issues of borders and migration. The on-line conference featured both provincial and national content that provided educators a unique opportunity to connect with history and social science teachers from across the country and continue their professional development and learning new tools and techniques in teaching history and social studies while facing the many challenges of teaching in the COVID-19 era. The director of the project Thinking Historically for Canada's Future Professor Carla Peck was also

involved in the virtual conference and the Alberta Teachers' Association Social Studies Council

The event included the founder of Black history month, The Honourable Jean Augustine as keynote speaker, over 30 workshop and panel sessions featuring teachers and leading academics, researchers, and others from government NGO's and educational organizations as well as an extensive and interactive virtual exhibitor room with over 25 exhibitors where delegates were able to view their resources and ask questions in real time. Over 500 delegates attended the conference.

The first shared the latest findings on the varying economic and social impacts of COVID-19 from Statistics Canada as well as survey data from the Association for Canadian Studies/Leger Marketing that had a focus on newcomers and minorities. The other session featured policy makers, researchers and immigrant service providers describing the challenges being encountered by newcomers in this unprecedented crisis.

The first of the web conference series was a resounding success, with 1263 online registrations and 921 participants who signed in via Zoom, most of whom were either policy-makers, practitioners or researchers. In addition to participation from across Canada, conference attendees also logged in from the United States, France, Spain, Switzerland, Netherlands, Egypt and the United Arab Emirates.

This event was the first virtual Metropolis Summit. To a degree, it replaced the Metropolis conference in Winnipeg that was cancelled due to the pandemic, but it focused on how the COVID-19 pandemic was affecting migration in Canada.

The conference was well attended and offered over 50 sessions attracting presenters and delegates from across Canada.

The conference program included five opening sessions, 51 workshop sessions, 34 roundtable sessions and 25 poster presentations over the course of the five-day conference period. We had up to six concurrent sessions with a total of 381 speakers (a single session had up to 5 speakers). A range of research, best practices and other relevant information pertaining to immigration, refugees and settlement was well represented in the sessions including presentations from academia, all-three levels of government, as well as representatives from immigrant server provider organizations and other pertinent NGOs. The sessions covered a wide range of research, practical applications and field comparisons in various provinces and jurisdictions. Over 1,000 individuals from every region of Canada registered for the conference.



Metropolis North America Migration Policy Forum COVID-19's Impact on Migration and Borders in Canada, the USA and Mexico, June 28-29, 2021

The event billed as the annual Metropolis North America (MNA) Migration Policy
Forum aimed to act as an important three-country platform for exchanging
evidence-based ideas and practices on migration and identities. The Forum enabled
participants to share knowledge and key lessons on policy issues in the United
States, Mexico and Canada as they pertained to the COVID-19 pandemic.

Presenters from Canada, The USA and Mexico included policy makers, mayors of border towns, academics and researchers.

The second day of the conference featured sessions that offered two country or three country comparisons of findings from the surveys associated with the research project, "COVID-19's differential Impact on Indigenous Peoples and Newcomers: A Socioeconomic Analysis of Canada, US and Mexico." This project is in partnership with the University of Manitoba and funded by the Canadian Institutes of Health Research (CIHR).



SOCIAL RESEARCH

One of the ongoing goals of the ACS is to conduct social research to better understand the cultural and political perspectives of Canadians, and to disseminate the information garnered.

Supported by Immigration, Refugees and Citizenship Canada, in 2020-2021, the Canadian Index for Measuring Integration (CIMI) moved to the 3.0 edition which featured its reframing as the Canadian Index for Measuring Integration and Inclusion (CIMII) project. Hence, in addition to the integration indicators, we are identifying inclusion indicators and they will be the object of indexing in the forthcoming iteration of the CIMII.

Over the course of this reporting period, the following activities were completed:

- Finalized the list of ten members of the Expert Advisory Committee (EAC).
- Explored Statistic Canada's Crowdsourcing Survey datasets and the annual Labour Force Survey (2019 to 2021) to better understand the impacts of COVID-19 on the outcomes of immigrants compared to the Canadian-born population.
- Developed the online CIMI learning tool to provide a cross-sectoral understanding on the state of immigrant integration in Canada.
- Updated the CIMI tool on www.integrationindex.ca, launched the COVID-19 Social Impacts webpage and incorporated e-learning tool link.
- Transferred knowledge to key stakeholders (settlement service providers, researchers, and policymakers) and engaged with CIMI users via our website, webinars, quarterly newsletters, and Measuring Integration and Inclusion Workshop series.

ENVISIONING THE FUTURE OF THE IMMIGRANT-SERVING SECTOR





In January 2021, the ACS commenced work on a two year project funded by World Education Services' (WES) Mariam Assefa Fund, entitled "Envisioning the Future of the Immigrant-Serving Sector." The project team is currently conducting nationwide research and consultations to discover how to strengthen the immigrant-serving sector so that it is more responsive, collaborative, innovative, and sustainable. The project team has already completed an extensive literature review/environmental scan to see how the COVID-19 pandemic has impacted the settlement sector, conducted two surveys for settlement organizations and newcomers and is in the process of completing 4 focus group discussions with a view to identify actionable solutions and recommendations to strengthen the settlement sector in the areas of funding, knowledge sharing, attraction and accessibility and capacity building. Eventually, the project team will be testing these proposed solutions in a project pilot phase, with the support of our implementation partners and toolkits will be developed and shared with the sector for evaluation and replication.

COVID-19 SOCIAL IMPACTS NETWORK & CIHR PROJECT

In March 2020 the ACS convened the *COVID-19 Social Impacts Network*, a multidisciplinary group of public servants, statisticians, social science and public health academics, and leaders of civil society organizations that met virtually on a weekly or bi-weekly basis to identify various research questions for the Canadian public, indicators for measurement and socio-demographics of interest incorporated into weekly surveys put into the field by Léger. The mission of the network was to generate the most timely results to track Canadian attitudes and behaviours as they relate to COVID-19 over time.

Results have been reported regularly (at least weekly/bi-weekly) across multiple news media platforms through a partnership that Léger established with Canadian Press as well as other media contacts.

Through the data generated and the partnerships formed through the virtual meetings, the ACS undertook additional research projects including:

- "An analysis of immigrant attitudes and behaviors during the COVID-19 pandemic" for Immigration, Refugees and Citizenship Canada
- Providing evidence-based responses to address the social and economic challenges of COVID-19 in the province of Manitoba for the Winnipeg Foundation

Virtual meetings of the COVID-19 Social Impacts Network continued into the 2021-2022 fiscal year.





COVID-19'S DIFFERENTIAL IMPACT ON INDIGENOUS PEOPLES AND NEWCOMERS: A SOCIOECONOMIC ANALYSIS OF CANADA, US AND MEXICO

Beginning at the end of summer 2020, the ACS research team has been partnering with the University of Manitoba for the research project, "COVID-19's differential impact on Indigenous Peoples and Newcomers: A socioeconomic analysis of Canada, US and Mexico," funded by the Canadian Institutes of Health Research (CIHR). The funding was awarded to Lori Wilkinson at the University of Manitoba. The ACS team contributes to the project with questionnaire development, quantitative analysis, translation, and website management. The project will be completed in 2022.

COMMUNICATIONS AND MEDIA



The year of 2020-2021 saw a change in personnel in the Communications department. The Communications Coordinator was merged with the E-Learning Coordinator position, and the Communications Coordinator moved to a newly created Events Coordinator position. The staff as of March 2021 is Director of E-Learning and Web and a Communications Assistant.

Key activities for the year were:

- the purchase of the Meltwater platform to more closely track ACS' coverage in traditional news and social media;
- the beginning of development for a weekly news digest to be sent out to subscribers;
- the commissioning of a new website to represent both ACS and Metropolis;
- a move towards web events, requiring greater communications support.



Owing to their depth, quality and relevance, findings from research conducted by the ACS is often referenced by the media on Canadian culture, perspectives and values. From April 1st 2020 to March 31st 2021, results from research conducted by the ACS were cited in over 27,000 press articles, across several Canadian provinces, but also nationally and internationally. From October 2020 to March 2021 (the only period for which there is available data), the ACS had the largest share of voice in traditional media in Canada when compared to the four other most cited non-profits in the same field (Figure 1).

Alternatives

The ACS primary means of communicating with its audience is through email. The number of email subscribers as of March 2021 is 10,220. The ACS uses social media platforms to reach multiple audiences across Canada and beyond. The ACS Twitter account (@CanadianStudies) presently has over 2,182 followers while the Metropolis Canada Twitter account (@MetropolisConf) currently has over 1,861 followers. The ACS maintains profiles Facebook and LinkedIn.

The ACS also continues to update its own www.acs-aec.ca and www.metropolisconference.ca websites with publications (including Canadian Diversity and Canadian Issues), research, studies, press articles featuring the ACS, various events, etc. However, the ACS is also working on launching a new website in the year 2021-2022 which will represent both brands, the ACS and Metropolis.



E-learning: uMetropolis

The year 2020-2021 saw online learning move from a vision to reality. uMetropolis is an online learning platform for knowledge and skill-sharing around immigration, diversity and inclusion. The target audience is researchers, service providers, community workers, and government employees.

The courses on the learning platform will be funded by partners interested in developing courses for this target audience and Canadian Heritage. The year's major activities were:

- hiring an e-learning coordinator;
- hiring a part-time Instructional Designer;
- the development of a web platform that will host ACS e-learning courses;
- content development for 3 courses:
 - o a CCUNESCO-commissioned course for the Coalition of Inclusive Municipalities;
 - Measuring Immigrant Integration in Canada a "how-to" course for the CIMI tool, partly commissioned by IRCC;
 - Reflections on Ancestry, Identity and the Peoples of Canada a course based on the Canadian Issues publication The Personal Past: History, Identity and the Genealogical Impulse.

Looking forward to 2021-2022, a strategic plan is in place to launch the platform to users at the 2022 Metropolis Conference. Course development will continue, while platform branding, marketing and development of new partnerships will be high priority.
